**ORDER ALLOWING DEBTOR(S) TO OBTAIN CREDIT
FOR MOTOR VEHICLE**

THIS MATTER came before the Court on Stipulation Allowing Debtor(s) to Obtain Credit for Motor Vehicle (“Stipulation”; ECF No. ____) between/among the Debtor(s) and the Chapter 13 Trustee consenting to the terms of this Order, after the Trustee was provided with loan/lease estimates and/or documents evidencing Debtor(s)’ inability to obtain financing at a lower interest rate. Debtor(s) have submitted a Stipulation requesting approval for financing/leasing a vehicle with reasonable terms. Debtor(s) also filed amended Schedules I and/or J disclosing the proposed loan/lease payment and demonstrating the continued feasibility of the Plan. Based upon the Stipulation, the Court finds cause to enter this Order.

IT IS HEREBY ORDERED THAT pursuant to 11 U.S.C. §364 and §365 the Debtor(s) shall be allowed to obtain credit to purchase or lease a motor vehicle on the specific terms and conditions as follows:

1. Payments to be paid by: Trustee Debtor(s)

6. Debtor(s) shall promptly provide to the Trustee a copy of the financing documents.
7. If, as a result of this transaction, there is a need for a Plan modification it shall be filed within 14 days of the entry of this Order.
